

Referral and Enrollment Process

Schedule a Tour

Reach out to our Client Services Manager to schedule a visit, ask questions, and learn more about our services and eligibility requirements.

Connect with Your FNRC Service Coordinator

Speak with your Far Northern Regional Center (FNRC) Service Coordinator about joining our program. They will submit a referral to WTC on your behalf.

Referral Review

Our team carefully reviews each referral to ensure a strong match between the program and your individual needs.

Enrollment Requirements

- Participants must be 18 years or older and require ongoing medical support.
- Nursing procedures and personal care needs will be assessed during intake.
- Participants must be able to function in a 1:3 staff-to-client ratio.
- Participants must be able to engage safely in the program environment.
- There are no mobility restrictions, though adaptive equipment must be in safe working order.
- Personal equipment used in the program must be maintained to ensure safety.
- Space is limited for individuals who use wheelchairs.
